

**GRAND COUNTY, UTAH
ORDINANCE 733 (2026)**

**ORDINANCE ESTABLISHING AND AFFIXING THE SALARIES OF ELECTED AND
STATUTORY OFFICERS OF GRAND COUNTY**

WHEREAS, Utah Code Annotated, Section 17-16-14, provides for the establishment by the County Legislative Body of salaries for county officers; and

WHEREAS, it is further stated no changes shall be made in existing salaries of county officers until the county legislative body in a county desiring to change existing salaries of county officers shall first hold a public hearing at which all interested persons shall be given an opportunity to be heard; and

WHEREAS, Ordinance 710 (2024) previously established the salaries of elected officials for calendar year 2025; and

WHEREAS, the County Commission wishes to maintain the salaries of all Grand County elected and statutory officers for calendar year 2026 at the same amounts established for calendar year 2025;

NOW, THEREFORE, the County Legislative Body of Grand County ordains as follows:
The annual salaries of the below elected officials shall be set as below for calendar year 2026:

Clerk/Auditor	\$ 111,485.84
Assessor	\$ 110,965.66
Treasurer	\$ 108,247.00
Recorder	\$ 108,680.70
Surveyor	\$ 46,681.37
Justice Court Judge	\$ 73,106.18
Commission Chair	\$ 44,974.48
Commission Member	\$ 40,103.31

This Ordinance shall be effective January 20, 2026 following one publication in the local newspaper.
